WILLIAM P. HARRIS and ELLA H. HARRIS
(hereinafter referred to as Mortgagor) SENDER(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of FOURTEEN THOUSAND SEVEN HUNDRED FIFTY AND 30/100 DOLLARS (\$ 14,750.00), with interest thereon from date at the rate of Five and three-fourths per centum per annum, said principal and interest to be repaid in monthly installments of One Hundred Ten and no/100 Dollars (\$ 110.00) each on the first day of each month hereafter until the principal and interest are fully paid, each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on either or no security;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the North side of East Prentiss Avenue, and being known as Lot No. 10 and a strip off the East side of Lot No. 11, on plat of property of Wilkins Cagle, which plat is recorded in the E. H. C. Office for Greenville County, South Carolina in Plat Book "F", at page 251, and having, according to a recent survey thereof made by Dalton & Neves, May, 1931, the following notes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the North side of Prentiss Avenue, which iron pin is 200 feet in a Westerly direction from the Northwest corner of the intersection of Prentiss and Eagle Avenues, and running thence N 32-10 E, 165.7 feet to an iron pin; thence N 59-02 W, 62 feet to an iron pin; thence S 34-55 W, 162 feet to an iron pin on the North side of Prentiss Avenue; thence along the North side of said Avenue S 55-50 E, 70 feet to the beginning corner.

This is the same property conveyed to us by deed of Louise H. Lindsey and others, dated April 26, 1982, to be recorded herewith.
