All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 12 on a plat of Section 11, Spring Forest Subdivision, recorded in the R.M.C. Office for Greenville County in Plat Book 828 at Page 34 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Spring Forest Road at the joint front corner of Lots 12 and 15 and running thence with said road N. 43-23 W. 110 feet to an iron pin; thence N. 43-55 E. 130 feet to an iron pin; thence S. 48-47 E. 118 feet to an iron pin; thence S. 36-39 E. 15 feet to an iron pin; thence S. 53-21 W. 140 feet to the point of beginning.
