and payable on demand, with interest thereon from date at the rate of 10 3/4% (prime rate as established by Community Bank, plus one (1) percent), per annum, to be paid monthly.

WHEREAS, the Mortgagor may hereafter become indebted to said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, situate, lying and being on the west side of Chinguapin Lane in the County of Greenville, State of South Carolina, being shown and designated as Lot 285 on a plat of Botany Woods, Sector VI, recorded in the REC Office for Greenville County, South Carolina, in Plat Book II, at Page 131, and having according to said plat the following notes and bounds, to-wit:

Beginning at a point on the west side of Chinguapin Lane, joint front corner of Lots 285 and 286, and running thence along the common line of said Lots S. 60-32 W. 211.4 feet to a point; thence N. 19-33 W. 42 feet to a point; thence N. 18-45 W. 141.4 feet to a point; thence N. 72-14 E. 191.6 feet to a point on the western side of Chinguapin Lane, joint front corner of Lots 284-A and 285; thence along said Chinguapin Lane S. 21-30 E. 100 feet to a point; thence still with the western side of Chinguapin Lane S. 29-15 E. 40 feet to the point of beginning.
