NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situated, lying and being in the State of South Carolina, County of Greenville, in Butler Township, on the southern side of S. C. Highway No. 296, and on the west side of a county road, and having the following metes and bounds, according to a plat made by C. O. Riddle, March 31, 1958, to-wit:

BEGINNING at a point at the intersection of the roads or highways aforesaid, and running thence along said county road S. 31-30 W. 658.3 feet to a point; thence continuing with said county road, S. 31-30 W. 937.2 feet to an iron pin or point in said road, 17 feet from an iron pin on the west side of said road; thence N. 62-28 W. 17 feet to said pin, and continuing on said course along line of J. P. Verdin land 438.4 feet (a total of 455.4 feet) to an iron pin on the southern side of said S. C. Highway No. 296; thence with said highway in an easterly direction to the beginning point, and containing approximately 15 acres, be the same more or less.
