MORTGAGE
(Construction)

THIS MORTGAGE is made this 9th day of March, 1981, between the Mortgagor, Cothran & Darby Builders, Inc., (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Eighty thousand eight hundred and 00/100 (80,800.00) Dollars or so much thereof as may be advanced, which indebtedness is evidenced by Borrower's note dated March 9, 1981, (herein "Note"), providing for monthly installments of interest, with the principal indebtedness, if not sooner paid, due and payable September 1, 1982.

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage and the performance of the covenants and agreements of Borrower herein contained, (b) the performance of the covenants and agreements of Borrower contained in a Construction Loan Agreement between Lender and Borrower dated March 9, 1981, (herein "Loan Agreement") as provided in paragraph 20 hereof, and (c) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 17 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant, and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being on the northerly side of the turning circle of Creekside Road, near the City of Greenville, South Carolina, and being designated as Lot No. 423, on Map Three, Section Two, Sugar Creek, and having according, to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Creekside Road, joint front corner of Lot Nos. 422 and 423, and running thence N. 61-07-09 E. 225.05 feet to an iron pin in the rear line of Lot No. 40; thence along the line of said lot N. 18-12 E. 14.7 feet to an iron pin; thence N. 75-27 W. 253.99 feet to an iron pin, joint rear corner of Lot Nos. 423 and 424; thence along the common line of said lots S. 0-06-42 E. 160.64 feet to an iron pin on the northerly side of the turn around of Creekside Road; thence around said Road on a curve the chord of which is S. 59-29-45 E. 50.93 feet to an iron pin, the point of beginning.
