THIS MORTGAGE is made this 22nd day of September, 1978, between the Mortgagor, James Oliver and Mamie Oliver (herein "Borrower"), and the Mortgagee, GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of SOUTH CAROLINA, whose address is 107 Church Street, Greer, South Carolina 29651 (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of SEVEN THOUSAND AND NO/100 (\$7,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated September 22, 1978, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on September 1, 1988;

To Secure to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land, with all improvements thereon, situate, lying and being in Chick Springs Township, said State and County, School District 285, in the City of Greer, on the north side of Hubert Street, and having the following courses and distances, to-wit:

BEGINNING at an iron pin at W. P. Duncan's corner and running thence S. 56-00 E. 83 feet to an iron pin; thence S. 16-30 W. 174 feet to a stake on Hubert Street; thence N. 44-30 W. 93 feet with Hubert Street to corner (now or formerly) of W. P. Duncan; thence N. 17-30 E. 157 feet to the point of beginning, and containing 30/100 acres, more or less.
