THIS MORTGAGE is made this 27th day of March 1981, between the Mortgagor, Premier Investment Co., Inc. (herein "Borrower"), and the Mortgagee, Carolina Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States whose address is P. O.
