### MORTGAGE

THIS MORTGAGE is made this 28th day of July, 1983, between the Mortgagor, JERRY W. KINGREY AND BARBARA L. KINGREY, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of FIFTY FIVE THOUSAND AND NO/100 Dollars, which indebtedness is evidenced by Borrower's note dated July 28, 1983, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on January ... 27, 1984.....;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 8 on a Plat of NORTHWOOD, Section 3, recorded in the RMC Office for Greenville County in Plat Book 9F at Page 90, and having, according to a more recent survey prepared by Freeland and Associates, dated July 7, 1983, entitled "Property of Jerry W. Kingrey and Barbara L. Kingrey", the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lot 8 and property of Franklin Clark Howell and running thence S. 66-34 E. 236.0 feet to an iron pin; thence turning and running with the creek as the line, S. 43-31-12 W. 109.2 feet to an iron pin; thence running with the line of Lot 9, N. 87-41 W. 196.0 feet to an iron pin; thence running with Bendingwood Court, the curve of which is N. 33-11-40 W. 47.0 feet to an iron pin; thence turning and running with the line of Lot 7, N. 32-34-54 E. 149.25 feet to the point of BEGINNING.
