BEGINNING at an iron pin on the northeast side of Stoneybrook Trail, joint front corner of Lots 49 and 50; thence with the joint line of said Lots, N 02-13 E, 205.8 feet to an iron pin near branch; thence with said branch as the line, the traverse line of which is N 69-10 E 50.2 feet to a pin; thence continuing N 57-29 E 70.65 feet to a pin near said branch; thence S 39-56 E 74.9 feet to an iron pin corner of Lot 51; thence with the line of said Lot, S 19-29 W 233.6 feet to an iron pin on the northeast side of Stoneybrook Trail; thence with the northeast side of said Trail, N 79-09 W, 86.2 feet to the beginning corner.

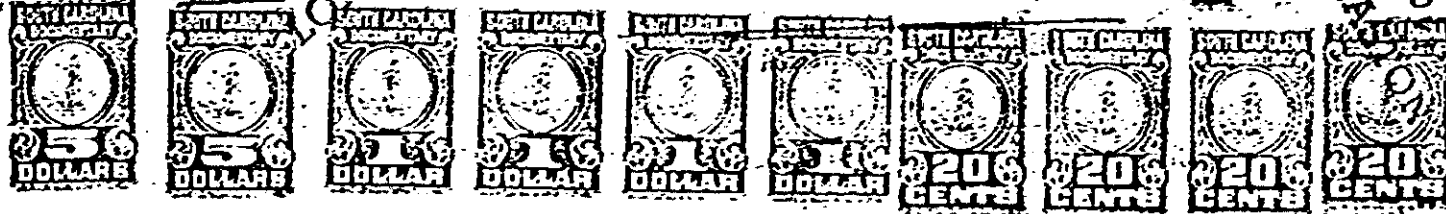
