THIS MORTGAGE is made this *13* day of *April*
 19 *83* between the Mortgagor *Donnie S. Tankersley*
 (herein "Borrower"), and the Mortgagee, The Citizens and Southern

WHEREAS Borrower has entered into an agreement with Lender under which the Lender agrees to lend to the
