SEND GREETING:

Whereas, we, the said PEACE-HAGOOD ASSOCIATES, A SOUTH CAROLINA GENERAL PARTNERSHIP,

to be paid on or before the 270th day after the date

with interest thereon from date
at the rate of 10 per centum per annum, to be computed and paid at maturity

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

ALL That certain piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, more particularly described according to survey made for Peace-Hagood Associates on November 11, 1983, by Carolina Surveying Company, 112 Manly Street, Greenville, S. C., as follows:

BEGINNING At an iron pin on the north side of McKay Street, 100.0 feet east of the intersection of McKay Street and Augusta Street, and running thence with old lot line, N. 13-05 W. 127.6 feet to an iron pin; thence turning and running N. 81-36 E. 79.9 feet to an iron pin; thence N. 11-19 W. 100.0 feet to an iron pin; thence 80-39 E. 20.0 feet to an iron pin; thence S. 11-18 E. 240.5 feet to an iron pin; thence along McKay Street S. 89-10 W. 96.5 feet to the point of beginning.
