Fowler, all of those Lots Nos. one and two in Block One in a plat of land known as Moores Heights in and near the Town of Simpsonville, S.C. same being the land conveyed to me by S.T. Moore, Map of which is to be filed with the C.C.C. of P. and made by J.R. Edmonds, C.E. Greensboro, N.C.
