in the State aforesaid in consideration of the sum of Seventy-five hundred Dollars, to me in hand paid at and before the sealing of these presents by

Riley J. Rowley (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Riley J. Rowley, his heirs and assigns an undivided one half interest of, in and to all that certain lot, piece or parcel of land situate, lying and being in the State of South Carolina and County of Greenville, in the Third Ward of the City of Greenville, bounded on the South by Broad Street, on the West by Jackson Street, on the North by Court Street and on the East by lot now belonging to J.E. Beattie (formerly belonging to Mrs. Mary Speer) and lot belonging to T.Q. Donaldson, the lot here described being the same lot conveyed to me by John B. Marshall the 23rd, day of February 1910 and recorded in Vol. 5, at page 737, for full identification, location and description of said lot, reference is hereby made to said deed and to the deeds therein referred to.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.
