

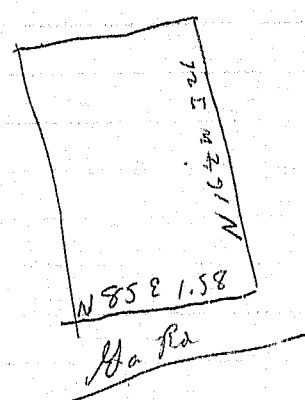
W. T. Jones Deed TO Zee Green

STATE OF SOUTH CAROLINA, COUNTY OF Greenville

KNOW ALL MEN BY THESE PRESENTS, That I, W. T. Jones of Simpsonville, S. C.

in the State aforesaid for and in consideration of the sum of One hundred and fifty Dollars, to me in hand paid at and before the sealing of these presents by Zee Green

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Zee Green all that lot or parcel of land lying, being and situate in the Town of Simpsonville County and State aforesaid, containing one-half acre, more or less and hath the following metes and bounds, to wit, bounded by Alley or Street, Zee Green, Georgia Road and others, Commencing in center of said Road running; thence N. 85 E. 1.58 to center of road; thence N. 16 1/2 W. 3.26 to a stone; thence S. 82 1/4 W. 1.55 to a stone; thence S. 16 1/2 E. 3.17 to beginning corner said lot No. 6.



TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Zee Green and his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said Zee Green, and his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
