acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
L. Jackson Green all that piece, parcel or lot of land situate, lying and being in the State
and County aforesaid, having the following metes and bounds:

Beginning at a point on an unnamed Street and runs; thence with said Street 82 feet; thence
S. 12 E. 170 feet; thence S. 88-1/2 E. 66 feet; thence N. 6-1/2 W. 164 feet to the beginning corner,
being known as Lot No. 19, Cureton Survey of April 1, 1908.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-
wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said
L. Jackson Green, his heirs and assigns, forever.
