

W.H. Bozeman Deed TO H.L. Todd

KNOW ALL MEN BY THESE PRESENTS, That I, W.H. Bozeman of Greenville County
in the State aforesaid
in consideration of the sum of Five hundred Dollars,

to me in hand paid at and before the sealing of these presents by
H.L. Todd, of the State and County aforesaid (the receipt whereof is hereby
acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
H.L. Todd, his heirs and assigns, All of that certain piece, parcel and lot of land situated
in the State and County aforesaid in the Town of Simpsonville on the North side of Curtis Street
adjoining lot of C.M. Todd and land of W.H. Bozeman and having the following metes and bounds:
Beginning on iron pin C.M. Todds corner and; thence with his line N. 23° 55' W. ninety (90)
feet to iron pin; thence N. 66-1/4 E. twenty-five (25) feet to iron pin; thence S. 23° 55' E.
Ninety (90) feet to iron pin on Curtis Street; thence with said Street S. 66-1/4 W. twenty-five
(25) feet to the beginning.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-
wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said
H.L. Todd, and his heirs and assigns, forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and
forever defend all and singular the said premises unto the said H.L. Todd, and his

heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to
claim the same, or any part thereof.
