T.A. Honour, Jr. (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

T.A. Honour, Jr. All that lot of land on Pendleton Road, just beyond the Incorporate limits of the City of Greenville, S.C. and near the Brandon Mills, known as No. 6 of Honour Row, measuring on Pendleton Road:

Beginning at No. 5, sixty feet West to No. 7; thence South two hundred feet (200) to Southern Railway right-of-way; thence East sixty feet (60) more or less to lot No. 5; thence North two hundred (200) feet, more or less to the Pendleton Road, being same land conveyed to me by Mrs. Rebecca C. Honour, Sept. 22, 1908 and recorded in Book E. page 100.

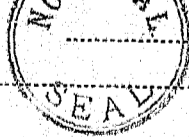
