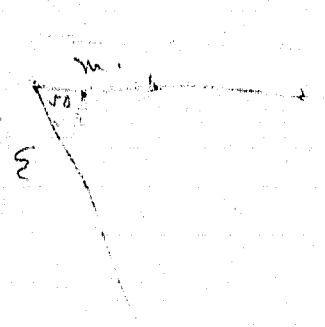
KNOW ALL MEN BY THESE PRESENTS, That I, C.H. Croskeys

in the State aforesaid
in consideration of the sum of One hundred and twenty-five Dollars
to me in hand paid at and before the sealing of these presents by

C.S. Rigby (the receipt whereof is hereby
acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

C.S. Rigby, all that piece, parcel or lot of land on the South-west corner of Elford &
Manley Streets in the City of Greenville, County of Greenville and State aforesaid, fronting
fifty feet on Manley Street and having the following metes and bounds:

Beginning at a stake on Manly St. (50 feet South-east of Elford St.) and running back at
right angles with said Manly St. fifty (50) feet to stake; thence in a straight line twenty
(20) feet and nine (9) inches to a stake on Elford St (about 56 feet from intersection of
said two streets); thence along Elford St. fifty-six (56) feet to corner of Manly St.; thence
along Manly St. fifty (50) feet to beginning corner, being a small vacant lot adjoining
tenant property and is a part of the lot formerly owned by Croft, et al deed to me being
recorded in R.M.C. office for said County in Vol. GGG, page 401.

wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

C.S. Rigby, and his heirs and assigns forever.

AND I do hereby bind myself & my heirs, executors and administrators, to warrant and
forever defend all and singular the said premises unto the said C.S. Rigby, and his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully
claiming or to claim the same, or any part thereof.
