(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said A.C. Davis, all that piece, or parcel of land in the City and County of Greenville and the State aforesaid, containing one eighth of an acre more or less, having the following boundaries: Beginning at the stake on the East side of Court Street; thence N.  $72\frac{1}{2}$  W. 1.02 $\frac{1}{2}$  chains to a stake 3X; thence N. 18 E. 1.24 $\frac{3}{4}$  chains to a stake on line of lot; thence S.  $72\frac{1}{2}$  E. 1.24 $\frac{1}{2}$  chains to a stake corner of lot 1 and 5; thence S. 18 W. 1.24 $\frac{3}{4}$  chains to beginning corner being same conveyed to me by Rev. E.B. Burroughs March 15, 1910.
