to me in hand paid at and before the sealing of these presents by

my son Edward W. Pike, (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Edward W. Pike, all that piece, parcel and lot of land situate, lying and being in the County and State aforesaid, about 2-1/2 miles North of the City of Greenville, East of the Buncombe Road: Beginning at an iron pin on North side of Bates Street, corner of lots 6 & 8 on survey of lands of H.P. Hammett, Estate; thence along said Street N. 87-2/3 E. 92-1/2 feet to an iron pin corner of lots 8 & 10; thence N. 2-1/3 W. 337-1/2 feet to an iron pin corner of lots 8 & 10; thence S. 58-1/2 W. 109-1/2 feet to an iron pin, corner of lots 6 & 8; thence S. 2-1/3 E. 285 feet to the beginning, containing 68/100 of an acre, more or less, known as lot No. 8 in W.A.
