KNOW ALL MEN BY THESE PRESENTS, That we, F.P. Berry and W.T. Berry of the County of Greenville, in the State aforesaid in consideration of the sum of Five thousand five hundred Dollars to us in hand paid at and before the sealing of these presents by

Hartwell R. Moseley (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Hartwell R. Moseley, all that piece, parcel or tract of land situate, lying and being in the State and County aforesaid, on waters of Reedy River, adjoining lands of T.T. Farr, E.E.-Watkins, William Hudgens and others, and having the following metes and bounds, to wit: Beginning at a stone in Cedar Lane Road, corner of William Hudgens land, and running; thence with said road N. 8 W. 17.00 to bend in the road; thence with said road N. 13 W. 9.05 to a stone in said road; thence N. 72-1/2 E. 21.00 ch. to a pine-stump; thence N. 64-1/4 E. 22.80 to a stone, E.E. Watkins corner; thence S. 49 E. 9.73 to a stake; thence S. 73 W. 14.50 to a stone (dogwood pointers); thence S. 15-1/4 E. 7.50 to stone; thence S. 63-1/2 W. 12.40 to a Black-gum stump OM; thence S. 4 E. 6.31 to a stone OM; thence S. 59-1/2 W. 23.60 with William Hudgens line to the beginning corner, containing 79 acres, more or less, as shown by plat of W.A. heirs and assigns, against us and our heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
