in the State aforesaid in consideration of the sum of Five hundred (\$500.00) Dollars to me in hand paid at and before the sealing of these presents by

W.W. Price, (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

W.W. Price, all my right, title and interest in that certain piece of property in the City of Greenville, State and County aforesaid, located on the corner of Perry Avenue and Calhoun Street, being the home place of Mrs. M.E. Price, said property fronting 167 feet on Perry Avenue and 410 feet on Calhoun Street, my interest therein being an undivided child's part.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said W.W. Price, his heirs and assigns forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said W.W. Price, his

heirs and assigns, against me and my and heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
