

J.E. Payne DEED TO J.T. Blessingame

KNOW ALL MEN BY THESE PRESENTS, That I, J.E. Payne

in the State aforesaid

in consideration of the sum of Four thousand Dollars

to me in hand paid at and before the sealing of these presents by

J.T. Blessingame (the receipt whereof is hereby

acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

J.T. Blessingame, his heirs and assigns, All that certain lot of land situate in Ward 5, in the City and County of Greenville, South Carolina:

Beginning at a stake on the West side of Markley Street, at the intersection of a ten foot alley, and runs thence S. 51 W. three hundred and eighty feet to another alley; thence along said alley in a Southern direction forty-nine feet to a stake, corner of lot owned by W.H. Irvine; thence N. 71 E. One hundred and four and one-half feet to a stake; thence N. 36.05 E. fifty-four feet to a stake; thence N. 62-1/2 E. Two hundred and fifty-two feet to a stake on Markley Street; thence with said Street N. 40 W. one hundred and eighteen feet to the beginning corner.

Also all that other lot of land situate in said Ward, City, County and State:

Beginning on the West side of Markley Street, on the corner of a lot owned by W.H. Irvine, and runs thence S. 71 W. four hundred and seven feet to an alley; thence S. 20 E. One hundred and forty-eight and one-half feet to a stake; thence N. 71 E. Two hundred and Sixty-two and one-half feet to a stake; thence N. 19-1/2 W. forty-eight feet to a stake; thence N. 71 E. One hundred and forty four feet to Markley Street; thence along Markley Street N. 19-1/2 W. One hundred and one-half feet to the beginning corner.

Also those four other lots situate in said County and State, and known and designated as Lots 1, 2, 3, and 4 in Block E. of the Melville Land Company, as shown by a plat of same recorded in Plat Book "A" at page 97, said four lots having been conveyed to me by said Melville Land Company.
