

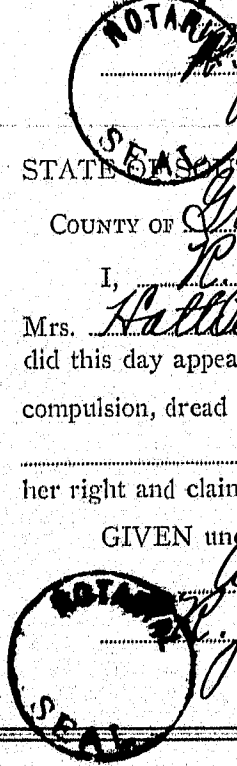

Berry*, all that certain parcel, and lot of land, situated *Lyons* and *burgh* in the State of South Carolina, in *Greenville County*, in the town of *Greer* on the north side of *Prace Street* having the following metes and bounds to wit: Beginning at a stone P.M. in center of *Prace Street*, *J.
