Hipps and Zadie Jones in the State aforesaid in consideration of the sum of Twenty-five hundred and eighty DOLLARS, to us in hand paid at and before the sealing of these presents by W.T. Thackston and S.A. Thackston (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said W.T. Thackston and S.A. Thackston, all that lot or parcel of land lying, being and situate in Austin Township, County and State aforesaid, containing sixty-four and one-half acres, more or less and hath the following metes and bounds to wit, bounded by lands of J.T. Thackston, Satterfield, Will Gaylord and others:

Commencing at a stone Will Garretta corner on East side of road running; thence N. 32 E. 6.90 to J.T. Thackstons corner; thence S. 86-1/2 E. 20.30 to a stone at branch; thence down said branch S. 66 E. 7.57 to a bend; thence N. 65 E. 6.66 to bend; thence N. 74-3/4 E. 5.50 to an ash near branch; thence S. 35 W. 37.28 to a stone; thence N. 40 W. 32.00 to beginning corner, the same being a part of the land conveyed to Margaret Thackston by R.M. Owings, April 27, 1862.

DEED TO David W. Moore

KNOW ALL MEN BY THESE PRESENTS, That I, John K. Ragsdale of the County of Greenville in the State aforesaid in consideration of the sum of Thirty-five hundred Dollars (\$3,500.00) DOLLARS, to me in hand paid at and before the sealing of these presents by David W. Moore (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said David W. Moore, his heirs and assigns all that certain tract or parcel of land situated in the County of Greenville and State aforesaid on the East side of the Piedmont Road, about two and three quarter miles South of said City of Greenville, adjoining lands of J.E. Earle, Jones and others, being a part of the Wallace Lands, containing thirty-two (32) acres, more or less, and having the following meets and bounds:
Beginning at a stone in the Piedmont Road; thence S. 81-1/4 E. 6.25 to a Mulberry on branch; thence with the meanders of said branch to stone in branch on old line; thence S. 81-1/4 E. 23.00 to a R.R. iron; thence N. 41-7/8 W. 20.55 to a stone and iron pin; thence N. 46-1/2 W. 8.00 to an iron pin; thence N. 82 W. 7.00 to an iron pin in Piedmont Road in center of same; thence with said road to the beginning corner.
