Bell, (1) All that certain lot of land situate near the city of Greenville on the outside of Rutherford Road, beginning at the Northwest corner of Rutherford Road and Mountain Avenue, thence along said Avenue S. 64° 36' E. 100 feet to corner, thence along line parallel with Rutherford Roads S. 28° 15' 45" E. 189 1/2 feet to a stake, thence N. 64° 30' W. 100 feet to Rutherford Road, thence with Rutherford Road N. 28° 15' 45" E. 189 1/2 feet to beginning corner being the same lot of land conveyed to W.
