in the State aforesaid in consideration of the sum of Five dollars and the further consideration stated above to me in hand paid at and before the sealing of these presents by

Jeane Victoria Latimer

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Jeane Victoria Latimer, all my right, title and interest, being an undivided one-half interest in all that certain tract of land situate in Butler Township, Greenville County, containing one hundred and five acres (105), more or less, as shown on a plat of the Latimer lands, made by F.G. Rogers, Surveyor, being tract "A" on said plat, and having the following metes and bounds: Beginning at a stake, corner of tracts "A and B"; thence N. 89-1/2 W. 250 feet to a stake in road; thence with said road N. 71-3/4 W. 230 feet to bend in road; thence with said road N. 88 W. 465 feet to corner of SMith and McCreary lands; thence with said line N. 1 W. 1208 feet to old Congaree Road; thence with said road N. 44-1/2 W. 810 feet to rock corner; thence N. 37 E. 232 feet to road to Greenville; thence with said road N. 84 E. 150 feet to a stone in road; thence N. 14-3/4 E. 2109 feet to stake; thence S. 77 E. 1350 feet to a stake corner tract "B"; thence with line of said tract S. 4-1/2 W. 3950 feet to the beginning corner.
