in hand paid at and before the sealing of these presents by (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

T. F. Dill All my real and personal property deeded to me by my Grand Father, J.P. Dill,
consisting of 3 tracts of land. 1st, one known as the A.P. Ballew place & contains 51 acres,
more or less & joins land of T.J. Lister, James Sudduth & others. 2nd. tract known as home
track containing 50 acres, more or less, joining lands John W. Moon, C.L. & J.T. Verdine &
others (T.F.Dill). 3rd. Track known as the J.M. Harrison land, containing 19 acres, more or less
bounded by lands, T.F. Dill, J.M. Harrison & others, lying on the northeast of Jordan Road
it being in Highland Township.

I hereby reserve my lifetime interest. I am to have & enjoy full controle of tracks No. 1 and 2
during my life and if I have any bodily heirs they shall enjoy full possession & control of
tracts No. 1 and 2 as I have during my life.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-
wise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

AND I do hereby bind my heirs, executors and administrators, to warrant and
forever defend, all and singular, the said premises unto the said T. F. Dill, his
heirs and assigns, against me and my heirs, and against
every person whomsoever lawfully claiming or to claim the same, or any part thereof.
