KNOW ALL MEN BY THESE PRESENTS, That I, A.C. Davis

in the State aforesaid

in consideration of the sum of Fifteen hundred & fifty DOLLARS, to me in hand paid at and before the sealing of these presents by

Susie Neese (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Susie Neese, all that lot or parcel of land in the City and County of Greenville, and State aforesaid in the Fourth Ward:

Beginning at a corner on Broad Street at corner of Ellen Miller's line and running with Ellen-Miller's line 134 to a corner of C. & W.C. Rail-road, and thence with said C. & W.C. Right of way 46 feet to corner of A.C. Davis and thence with A.C. Davis line 134 feet to corner on Broad Street and thence with Broad Street 46 feet to the beginning corner, being a part of lot of land formerly owned by Elizabeth Parks, recorded in Vol. C.C.C. page 728.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.
