in the State aforesaid in consideration of the sum of Fifteen hundred and eighty (\$1580) DOLLARS, to me in hand paid at and before the sealing of these presents by

G.W. Bishop

(the receipt whereof

is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

G.W. Bishop, All that piece, parcel or tract of land situate, lying and being in the State and County aforesaid, in Bates Township, about twelve miles North of Greenville C.H. known as a part of the S.S. Crittenden lands, and has the following metes and bounds; to wit. Beginning at a pine thence S. 82-3/4 W. 17.08 ch. to a stone; thence S. 24-3/4 E. 15.96 ch. to a stone; thence N. 79 E. 4.52 ch. to a stone; thence N. 64 E. 5.15 ch. to a stone; thence N. 56-1/2 E. 8.97 ch. to a stone; thence N. 89-1/2 E. 7.74 ch. to a stake on the right bank of Tibbs branch waters of Enoree River; thence N. 1 E. 5.85 ch. to a stake; thence N. 1-1/2 W. 4.30 ch.; thence N. 11 W. 3.63 ch. to a stone; thence S. 74-1/2 W. 14.00 ch. to the beginning corner, containing thirty-nine (39-1/2) and one-half acres, more or less, adjoining land of the S.S.
