Pictor, all that lot of land, consisting of lot 43 and a part of lot 42 of South Cherokee Park, a part of which is recorded in Plat Book A page 130 in the office of the R.M.C. of Greenville County, described as follows: Beginning on Grantee Avenue N27 E 100 (one hundred) feet; thence S 76 3/4 W 74 feet to an alley; thence with said alley S 27 W 100 feet corner of lots 43 and 44; thence S 63 E 174 feet to the beginning corner. TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

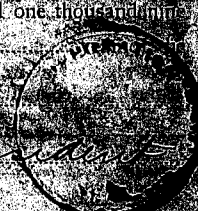
TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinafter named, and her heirs and assigns forever.
