a corporation chartered under the laws of the State of South Carolina and having its principal place of business at
near Greenville in the State of South Carolina for and in consideration of the
sum of One Hundred thirty two 100.00 DOLLARS,
to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby
acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

Cora T. Tammahill all that piece, parcel or lot
of land in Greenville County, South Carolina,
beginning at corner of Henry Stradley and
Sans Souci Country Club this being the
northeast corner of Stradley's lot and run
ning N. 46.32 E. twenty seven and one-half
feet to a stake, thence S. 60-108 Three hundred
nine feet to a corner of Sans Souci Country
Club and Cora T. Tammahill, marked Twin Oaks
and Country Club Plot; thence with line of
Tammahill and Country Club S. 63.25 W. one
hundred twenty one and seven tenths feet
to iron pin, corner of Tammahill, Stradley and
Country Club; thence with line of Stradley and
Country Club N. 43-28 W. two hundred sixty one
feet to beginning corner, containing forty-four
hundredths of an acre, more or less

thereof.
