KNOW ALL MEN BY THESE PRESENTS, That Victor Monaghan Milled

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Five Hundred DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

J. M. Glenn all that certain piece of land situated and being in the County and State aforesaid, near the City of Greenville this being lots numbered fifty-three (53) and fifty-four (54) sub-division known as Monaghan Annex, part of which is recorded in plat book "C" office Registrar of Mineral Conveyance, Greenville County.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee...hereinabove named, and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee... hereinabove named, and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

In witness whereof the said granting corporation has caused its corporate seal to be hereunto affixed and these presents to be subscribed by its duly authorized officers, W. C. Beattie Treasurer and Thomas M. Marchant, Vice President on this the 29th day of June in the year of our Lord one thousand nine hundred and Eighteen and in the one hundred and forty-first year of the Sovereignty and Independence of the United States of America.
