

Cagle Park Company DEED TO *Cecelia Schultz Morris*

COUNTY OF *Greenville*

KNOW ALL MEN BY THESE PRESENTS, That *Cagle Park Company*

a corporation chartered under the laws of the State of *South Carolina* and having its principal place of business at *Greenville* in the State of *South Carolina* for and in consideration of the sum of *Fifteen hundred (\$1500.00)* DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto...

Cecelia Schultz Morris, All that certain lot of land situate in the City of Greenville, County and State aforesaid, known and designated as lot 64, Block A., Cagle Park as shown on plat recorded R.M.C. Office Greenville County, Plat Book C., page 238, more particular described as follows: Beginning at an iron pipe on the north side of Tindal Avenue corner of lot 63 and running thence with line of lot 63 N. 2-37 W. 199.3 feet to an iron pipe on McKay Street; thence with McKay Street N. 89-15 E. 65 feet to an iron pipe corner of lot 65; thence with line of lot 65, S. 1-09 E. 199.1 feet to an iron pipe on Tindal Avenue; thence with Tindal Avenue S. 89-07 W. 60 feet to the beginning corner. Subject, however, to the following restrictions, which are part of the consideration for this deed, and are made for the benefit and protection of the other lots shown on the plat above referred to, which restrictions shall remain effective for a period of twenty years from the date of this deed, to-wit:

1. The property herein conveyed nor any part thereof shall not be sold, rented or otherwise disposed of to Negroes.
2. The said property shall not be used for any unlawful business nor for anything which would constitute a nuisance.
3. The property herein conveyed shall not be recut nor subdivided so as to face any other direction than as shown on said plat.
4. No building shall be erected upon said property within 25 feet of the present line of Tindal Avenue.
5. No building costing less than \$2500.00 shall be erected upon said lot other than out-buildings appurtenant to a dwelling.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee... hereinafter named, and... *her* heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee... hereinafter named, and... *her* heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

In witness whereof the said granting corporation has caused its corporate seal to be hereunto affixed and these presents to be subscribed by its duly authorized officers, *W.P. Anderson, President and A.B. Houston, Sec.* on this the *22nd* day of *May*, in the year of our Lord one thousand nine hundred and *Nineteen*, and in the one hundred and *Forty-third* year of the Sovereignty and Independence of the United States of America.
