KNOW ALL MEN BY THESE PRESENTS, That Day-Kloechler Building Company,

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville, South Carolina in the State of South Carolina for and in consideration of the sum of Ten Dollars and other valuable consideration DOLLARS to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

A. J. Day, his heirs and assigns forever; All that piece, parcel or lot of land situate, lying and being just South of the corporate limits of the City of Greenville, County and State aforesaid, on Catechee Road, and having the following meter and bounds, to wit: Beginning at an iron pin on Catechee Road, joint corner of Lots 74 and 75, and running thence S. 75-45 W. 60 feet to an iron pin, joint corner of Lots 73 and 74; thence with line of Lot 73 N. 14-15 W. 188 feet to an iron pin; thence N. 75-45 E. 60 feet to an iron pin; thence S. 14-15 E. 188 feet to the beginning corner, and being Lot No 74 on Plat of Cherokee Park recorded in Plat Book C, page 96, and being the same lot conveyed to us by W.
