KNOW ALL MEN BY THESE PRESENTS, That S. L. B. Armstrong

in the State aforesaid in consideration of the sum of Twenty hundred DOLLARS, to me in hand paid at and before the sealing of these presents by S. L. Coleman of Greenville County (the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

S. L. Coleman all that lot or parcel of land lying, being and situate near the town of Fountain Inn in Coppenhagen State aforesaid and containing thirty seven acres more or less and Rath the following metes and bounds to-wit: Bounded by lands of Mrs. Mary Picie Vaughn, John R. Harrison, and others commencing at a stone near a post oak J. R. Harrison's corner running thence S. 14 1/4 N. 6.92 to a poplar, thence N. 89 1/4 W. 19.90 to a stake, thence in Mrs. Mary's line thence N. 86 1/2 E. 20.00 to maple on branch, thence across said branch 16.35 to a stone on John Nelson's line just above a bridge, thence with Nelson N. 66 3/4 E. 4.58 to a stump thence N 2 1/2 E. 7.00 to beginning corner the same conveyed to me by S. P. Armstrong the 15th day of May 1906 also one other lot at the same place and with the following metes and bounds to-wit: Bounded by John R. Harrison, John A.
