in consideration of the sum of Three Hundred Eighty Two & 50/100 DOLLARS,
to me in hand paid at and before the sealing of these presents by

Mary A. Drake, (the receipt whereof
is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

Mary A. Drake, All that certain lot of land, situate in thr County and State aforesaid
about three miles from the Ciyt of Greenville in the Vicinity known as Fallis and located
on the west side of the White Horse Road and having the following metes and bounds to wit;
Beginning at a pin on the West side of the White Horse Road and running thence, S.64-30 W.
four hundred feet to a pin, thence S.24 E. Sixty three feet to a pin, thence N. 64-30 E.
four hundred feet to a pin on the White Horse Road, thence N. 24 W. along said White Horse
Road, sixty three feet to the beginningpoint and being a part of the same lay of land con-
veyed to me and R. A. Brown by W.G. Trotter, by his deed of Dec. 15th. 1911 and being
