in the State aforesaid in consideration of the sum of Five dollars & other valuable consideration DOLLARS, to me in hand paid at and before the sealing of these presents by

W.P. Smith (the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

W.P. Smith, all that piece, parcel & tract of land situate in O'Neal Township, County & State aforesaid & having the following boundaries, beginning at a stone corner by Gilreath Road & running thence S. 16° 25' E. 8.30 chains to a stone cor. thence N. 79-1/2° W. 11.80 chains to a stone cor. thence S. 75-1/4° W. 7.0 chains to a stone cor. thence N. 24-1/2° W. 3.41 chains to cor. on edge of branch & road, thence N. 75-1/4° E. 7.35 chains to a stone cor. OM, thence N. 28° E. 2.0 chains to stone cor. OM, thence N. 85-3/4° E. 11.50 to point of beginning, & containing ten acres & forty six one hundredths (10-46/100) be the same more or less.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.
