KNOW ALL MEN BY THESE PRESENTS, That We, Willie Cox, Jesse Cox, Arthur Cox, Mary Boswell, Jerry Cox and Lizzie Goodwin in the State aforesaid County of Greenville and John Cox and in the further consideration of One DOLLAR, in consideration of the sum of an equal partition and division of the estate of me in hand paid at and before the sealing of these presents by Willie Cox, Jesse Cox, Arthur Cox, Mary Boswell, Jerry Cox and Lizzie Goodwin (the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

Jane Cox all that piece, parcel or tract of land situate, lying and being in the State and County aforesaid on North Saluda River, and has the following metes and bounds. Beginning at stake in River Road and running down said road 1.33 to bend, thence 3.06 to bend, thence 3.89 to bend, thence 3.12 to stake X in said road, thence S. 77-1/2 E. 8.14 to stake X on North Saluda River, thence up said river 4.68 to stake X; thence N. 33-3/4 W. 8.34 to beginning X and containing seven (7) acres, more or less.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Jane Cox, and her heirs and assigns, forever.

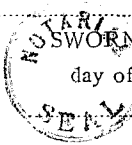
AND We do hereby bind ourselves and our heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Jane Cox and her
