KNOW ALL MEN BY THESE PRESENTS, That I, A. L. Nash of Laurens, S. C.

for and in consideration of the sum of Two thousand seven hundred and thirty-nine DOLLARS, to me in hand paid at and before the sealing of these presents by

Mrs. M. A. Westmoreland, in the State aforesaid (the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

Mrs. M. A. Westmoreland, all that piece, parcel or tract of land lying, being and situate in Greenville County near Laurens County Line, containing eighty-three acres, more or less, bounded on the North by M. P. Nash, East by Rufus Babb, South by Wm. Taylor and West by Robt.-Thomason & Thos. Coker.

The same being the place deeded me 11th, March 1907 by H. B. Stewart and the boundaries will more fully appear on said deed.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

Mrs. M. A. Westmoreland and her heirs and assigns, forever.
