KNOW ALL MEN BY THESE PRESENTS, That We, W.T. Henderson, H.W. Hunt and T.F. Hunt  
 in the State aforesaid  
 in consideration of the sum of Three hundred DOLLARS,  
 to us in hand paid at and before the sealing of these presents by  
 Wilkins Cagle (the receipt whereof  
 is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

Wilkins Cagle his heirs and assigns, all that certain piece, parcel or lot of land situate in  
 Greenville County, State aforesaid, near the western line of the City of Greenville on and a  
 part of a subdivision known as City View: Beginning at a stake on Henderson Street, joint  
 corners of lots Nos. 73 & 74 and running thence in a northerly direction with Henderson  
 Street 100 feet to a stake, joint corners of lots No. 71 & 72, thence with said joint lines in  
 an Westernly direction 150 feet to a ten (10) foot alley; thence along said alley in a southerly  
 direction 100 feet to a stake joint corners of lots No. 73 & 74; thence in an Easternly  
 direction with said joint lines 150 feet to a stake at the beginning corner, being lots Nos.  
 73 & 72 according to a plat made by W.A. Adams, surveyor and recorded in the office of R.M.C.  
 for Greenville County and being a part of the land purchased by us from J.H. O'Neall.

 forever defend, all and singular, the said premises unto the said Wilkins Cagle, his

heirs and assigns, against ourselves and our heirs, and against  
 every person whomsoever lawfully claiming or to claim the same, or any part thereof.
