KNOW ALL MEN BY THESE PRESENTS, That I, N.H. Harris

in the State aforesaid
in consideration of the sum of Thirty-eight hundred and twenty DOLLARS,
to me in hand paid at and before the sealing of these presents by

W.M. Blessingame, Jr. (the receipt whereof
is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

W.M. Blessingame, Jr., his heirs and assigns, all that tract or lot of land situate in the
County and State aforesaid, beginning at a stake in branch on Earle's land, and running thence
N. 9.30 W. 2.46 to stone and iron pin; thence N. 79.10 E. 2.00 to S. 4.; thence N. 64.45 E.
2.82 to stone; thence N. 62.20 E. 5.32 to iron pin; thence N. 46.40 E. 9.88 to iron pin; thence
N. 84.40 W. 35.70 to stake; thence S. 48 W. 3.95 to stone; thence N. 86.30 W. 1.12 to large
rock in creek; thence up the meanders of said creek 29.65 to the beginning 3x, and contains
38.2 acres, be the same more or less, being the same land conveyed to me by John Yown by deed
dated the 15th day of December 1903, and recorded in Vol. L.L.L. at page 263.
