KNOW ALL MEN BY THESE PRESENTS, That We, Suther Cox, Atha Cox, and Lodicer Cantrell

in consideration of the sum of four hundred fifty DOLLARS
to us in hand paid at and before the sealing of these presents by S. B. Johnson
(the receipt whereof is here- by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said S. B. Johnson all our right, title and interest in, and to all that piece, parcel or lot of land in Cleveland Township, Greenville County, State of South Carolina, on both sides of Gap Creek, waters of Middle Saluda River, adjoining lands now or formerly owned by Mary A. Mullins, James Mullins, and others, beginning on a Spanish oak on the Edwards Survey, near the road, thence N. 40° W. with the Edwards Survey 7.80 chains to maple 37, thence with Gap Creek back to the first branch, thence with said branch to the Gap Creek Road, thence down with the road to the Muddy Branch, thence up the Muddy Branch to the head to Mary Anderson's line; thence with Mary Anderson's line to the stone corner on the Nimrod Carroll land; thence with said line to Mary A. Mullins' line; thence with said line to the back line; thence with Nimrod Cantrell's line to the beginning, except the mill site, which is beginning on the creek where the road crosses the creek; thence up said creek to where the race starts, thence ten yards on each side of said creek down to the cleared land, and two hundred yards on the mountain to Reaves' Spring; thence with spring branch to creek; thence with the creek to the beginning, containing one hundred and fifty acres, more or less.

This deed conveys the entire fee in the above tract of land with the exception of a child's interest held by Betty Poole and a similar interest by Esie Johnson, both of whom are minors. It is the intention of this deed to convey every thing which was conveyed to Suther Cox by deed of R. M. Johnson et al, dated February 14th, 1910, recorded in office of R. M. C. for Greenville County in Book 8, page 173; and also the separate interests of Atha Cox and Lodicer Cantrell.

KNOW ALL MEN BY THESE PRESENTS, That we, Sarah Cox, Ma Pritchett, Mamie Johnson, Emma Waldrop, Pleasant Cox and Henry Cox in the State aforesaid in consideration of the sum of five DOLLARS to us in hand paid at and before the sealing of these presents by Suther Cox (the receipt whereof is here- by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Suther Cox all our right title interest and estate in the real estate of which the said Pleasant Cox died seized and possessed in tract No. 2 described and being as follows, in Greenville County and in Caluda Township, with the Saluda River and being by the following metes and bounds: Beginning at a stone on the west bank of North Saluda River 40 on the line between tract No. 1 and tract No. 2 of the estate of Susan Cox of thence running along bank of said river N. 45° E. 100 feet to a stake on bank thence across said River S. 41.26° W. 100 feet to a stake on east bank and on the line of R.
