Mills, his heirs and assigns, all that lot of land situate in the County and State aforesaid, in what is known as Sans Souci Villa, beginning at a point on the Franklin Road, and runs E. 57° 25' S., one hundred and seventy feet along Young Street; thence N. 57° 25' E., one hundred and seventy feet along Young Street; thence N. 57° 25' W., 156 feet to the Franklin Road; thence S. 32° 35' W., 168 feet to the beginning corner; being part of the lands conveyed to me by Suburban Land Company by deed, dated the 18th day of November, 1913, and recorded in Vol. 92, page 43.
