 in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bar-  
 gain, sell and release unto the said Norris Brothers, Incorporated  
 all that piece, parcel or lot of land in Township, Greenville County, State of South Carolina.  
 in the City of Greenville, on the north side of Birnie Street: Beginning at a stake on line of Norris Brothers and running N. 30 E. 306.5 feet to line of Southern Railway Right-of-way (C. & G. Division); thence along said right-of-way N. 59 W. 102 feet to an iron pin; thence S. 30 W. 308 feet to an iron pin on Birnie Street; thence with Birnie Street S. 60-15 E. 102 feet to the beginning.
