BALLENGER, referred to herein as "grantors", and being the owners of the land herein referred to, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto Victor Manufacturing Company the right to maintain and operate the said dam at its present height and to thereby pond the waters of South Tyger River with the right to repair and replace any part or the whole of said dam to its present height. And we do hereby release said Victor Manufacturing Company and Apalache Mills from all damage, present or future, to our lands situate in the County and State aforesaid and lying upon said stream.

Together with all and singular the Rights, Members, Hereditaments and Appurtenances thereto belonging or appertaining.

TO HAVE AND TO HOLD all and singular the said rights and privileges unto the said Victor Manufacturing Company, its successors and assigns forever.

And we do hereby bind ourselves, our heirs, executors, administrators and assigns to warrant and forever defend said premises unto the said Victor Manufacturing Company, its successors and assigns against us and our heirs and every person whomsoever lawfully claiming or to claim the same or any part thereof.
