This Indenture, between Flora L. Greene the Lessor and J.M. Gilbert, the Lessee, Witnesseth:
That the Lessor agrees to lease to the Lessee the tract of land situate in said County, containing
45 acres, known as the Luther L. Greene place in Austin Township, Greenville County, for
agricultural purposes.

To hold the same to the Lessee from the first day of January 1918, to the thirty-first day of December 1918.

And the lessee on his part agrees to pay to the Lessor, as rent for the same 1000 Lbs. white lint cotton—of all the cotton, corn, fodder, cotton seed, wheat and everything grown on the place, which shall become due as soon as gathered, and delivered at Flora L. Greens residence.
