Frank White of Greenville County, in consideration of the sum of Seven hundred and fifty DOLLARS, to me in hand paid at and before the sealing of these presents by A. McGee (the receipt whereof is hereby acknowledged), have Granted, Bargained, sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

A. McGee, All that certain piece, parcel and lot of land situate, lying and being near the City of Greenville, in the County and State aforesaid and being a part of a sub-division of land known as City View and being a portion of lot No. 11 A., Block J., according to a Plat of said sub-division recorded in the R.M.C. Office for Greenville County, in plat book "C", at page 112, fronting fifty feet (50) on the New Cut road: Beginning at an iron pin on said Road, fifty feet from the corner of said New Cut Road and Smith Street and running back in a Northerly direction, one hundred and forty-three and one-half (143 1/2) feet, more or less to a wire fence and iron pin on the line between the lot herein conveyed and the lot or strip of land heretofore conveyed by me to A.W. Cruikshank and T.F. Hunt (the receipt whereof is hereby acknowledged), have Granted, Bargained, sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

R.L. Cruikshank and T.F. Hunt, All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, a short distance west of the corporate limits of the City of Greenville, on the northwest corner of the Cedar Land Road or Hampton Ave. and Munroe Street and having the following metes and bounds: Beginning at a stake on said corner and running thence with Cedar Lane Road N. 39 W. 80 feet to stake; thence N. 47 1/2 E. 90 feet to stake; thence S. 59 E. 50 feet to stake on Munroe Street; thence with said Munroe Street S. 31 W. 105 1/2 feet to the beginning corner, being known as lot No. 7 on plat of Traxler property made by F.G.
