KNOW ALL MEN BY THESE PRESENTS, That

J. S. J. Jennings

is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

J. Hudson Williams, his Heirs and Assigns; All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, in the City of Greenville, in Block bounded by Main, Broad and Jackson Streets and Reedy River, and having the following boundaries: Beginning at a point eighty-three-hundredths ( $83/100$ ) of one (1) foot S. 19.44 W. from the corner of the Old Markley blacksmith shop at the Southwest corner of two alleys, and running thence with one of said alleys (the new line thereof as laid on the plat herein-after referred to) N. 69.30 W. forty-six and thirty-three hundredths ( $46-33/100$ ) feet to a point on West Wall of blacksmith shop where alley widens from fifteen to twenty feet; thence S. 19.44 W. with the West wall of said blacksmith shop, ninety-nine and seventy-eight-hundredths ( $99-78/100$ ) feet to the South Wall of said building on a court; thence with the line of said South Wall, S. 69.30 E. forty-six and thirty-three-hundredths ( $46-33/100$ ) feet to the corner of said building on the cross alley; thence with the said alley N. 19.44 E. ninety-nine and seventy-three-hundredths ( $99-73/100$ ) feet to the beginning corner, being the lot covered by the blacksmith shop formerly owned by Markley Hardware and Manufacturing Company, and afterwards sold to Markley Realty Company, except a strip eighty-three-hundredths ( $83/100$ ) of one (1) foot in width which is to be cut from the Northern portion of the lot occupied by said shop, in order to make the Alley the uniform width of fifteen (15) feet, and being shown as lot no. 11 on Plat of Markley Realty Company made by J. E. Surrine; dated March 26th, 1914, and marked N.B. - 261; this being the same or lot of land conveyed to me by J. Hudson Williams by deed dated the 22nd day of October, 1914, deed recorded in Vol. 16, at page 184. Also all those two certain lots, pieces and parcels of land situate, lying and being in the 3rd Ward of the City of Greenville, in the County of Greenville, State of South Carolina, described respectively as follows: First: That lot beginning at an iron pin on Rutherford Street, 100 feet South of Cedar Street and running thence a Southwesterly direction, 159 feet to an iron pin at the corner of Rutherford Street 77 feet more along to an iron pin, thence in a Westerly direction 159 feet to an iron pin at the corner of Mrs. M. F. Simpson's lot; thence in a Northwesterly direction 56 feet to the iron pin at corner of Dr. C. A. Simpson's lot; thence in an Easterly direction the boundary line of Dr. C. A. Simpson's lot, thence on the East side of Rutherford St. on the South by the lot of the same Mr. Simpson described on the West by the lot of S. J. Jennings (formerly known and used as Mr. C. A. Simpson's Second lot); that lot adjoins said lot above, beginning at a corner of Mrs. Caroline Pool's property, and running thence in a northerly direction with said Rutherford street 75 feet and so forth to a stone iron pin on said street; thence in a Westerly direction, 12 feet and so forth to a stone iron pin on lot now or formerly belonging to W. J. Bonds; thence in a southerly direction 75 feet to an iron pin on the lot now or formerly belonging to Mrs. Caroline Pool, thence along her line in an Easterly direction to the beginning corner on Rutherford Street; being bounded on the East by said Rutherford Street; being bounded on the East by said Rutherford Street; being bounded on the West by the lot just above described as being situated on Rutherford Street, on the West side of lot now or formerly belonging to W. J. Bonds, and on the South by lot now or formerly belonging to Mrs. Caroline Pool; being the same lot, conveyed to me by J. Hudson Williams by his deed dated the 23rd day of October, 1914; deed recorded in Vol. 16, at page 185.

Also all that lot or parcel of land situate, lying just outside the City of Greenville, in County and State aforesaid, near the Brandon Cotton Mill on Woodside Avenue, fronting ninety feet on said Avenue and having a depth of one hundred and fifty feet, said lot consisting of lot No. 13, a lot forty feet of the adjoining lot No. 12 of the Bonwood property conveyed to Julius H. Heyward by S. K. Clyde, Trustee and others, a plot of which is recorded in R. M. C. office for Greenville County in Plat Book A, to page 462 and 463; this being the same lot of land conveyed to me by J. W. Gray, Master, by deed dated the 8th day of August, 1914, deed recorded in Vol. 14, at page 213.
