KNOW ALL MEN BY THESE PRESENTS, That *The Plaintiff J. W. Morgan and wife*  
*Jane A. Morgan, 1881*

in the State aforesaid  
in consideration of the sum of  
One Thousand and One Hundred and Twenty Dollars,  
to *see*, in hand paid  
at and before the sealing of these presents by *J. W. Morgan*

(the receipt whereof

is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said  
*J. W. Morgan, his heirs and assigns, all that certain lot*  
*of land situate in Ward one of the City of Greenville, County*  
*and State of South Carolina, and designated by lot No. 5, as*  
*now or hereinafter recorded by the Deed Recorder registered, and recorded in the*  
*R. M. C. office of the said County in Book C at page 210; said lot*  
*fronting on the south side of Jones Street and being the following*  
*lines, courses and distances to wit: Beginning at an iron*  
*stake on Jones Street, corner of lot No. 4, thence with*  
*line of lot No. 4 N. 0° 08' W. two thousand feet and twenty-six and*  
*one-tenth (226-1/10) feet to iron stake in line of lot No. 3,*  
*thence with line of lot No. 3 N. 87-37/46' ninety-one and 1/10 (90-1/10)*  
*feet to iron stake corner lot No. 6, thence with line of lot No.*  
*No. 6 S. 0° 41' E. two hundred and thirty-seven and 8/10 (237-8/10) feet*  
*to iron pipe in line of Jones Street, thence with Jones Street*  
*N. 85-02' E. ninety (90) feet to the beginning, being a part of*  
*the property formerly known as "The Grace & Hobbs" property.*  
*The grantor reserves as a part of the consideration, assuming the*  
*payment of all assessments for street improvements and*  
*sidewalks on Jones Street. This conveyance is made subject*  
*to the following restrictions, which shall be binding upon*  
*the grantee, his heirs and assigns: (1) No dwelling shall be*  
*erected on said lot nearer than fifty (50) feet to Jones Street*  
*and this distance is declared to be the building line for this and*  
*the other lots owned by the grantor fronting on Jones Street.*  
*(2) No dwelling shall be erected upon said lot containing less*  
*than six thousand (\$6,000.00) Dollars. (3) If any garage*  
*or stable shall be erected on the lot herein granted, the*  
*nearest line of such buildings shall not be nearer to lot*  
*No. 3 than twenty-six (26) feet. The grantor agrees to insert*  
*restrictions numbered 1 and 2 in all deeds which shall be made*  
*by the grantor to lots fronting on Jones Street.*
